 - 2.3.9. SUNY Academic Programs & Awards committee Ophelia Morey
- 2.3.9.1. Review Distinguished Faculty Award
 - We are currently revising the guidelines for academic years 2019 20 and 2020 2.3.9.1.1. 21. This will include removing the word "transformational" for the Distinguished Librarian criteria. The layout and titles of the Distinguished Faculty Ranks are under discussion where it was decided that we would vote on whether to recommend changes to the guidelines from the current three separate ranks (Distinguished Professor, Distinguished Service Professor and Distinguished Teaching Professor) to a single rank of Distinguished Professorship under which there would be three categories: 1. Scholarship/Research/Creative Works, 2. Service, and 3. Teaching. I suggested having a fourth category titled Librarianship, but the committee did not support, therefore Distinguished Librarian (DL) will remain as a separate category. However, the Universitywide Advisory Council on Distinguished Librarianship will offer suggestions to the P&A committee for creating three categories under DL. The committee vote was positive for recommending to University Faculty Senate (UFS) the change to a single rank of Distinguished Professorship. Therefore, the next steps for the P&A committee are to consult with the Faculty Council of Community Colleges, and to form a subcommittee to draft a resolution for presentation at the UFS plenary in April.
 - 2.3.9.1.2. In addition, the UFS approved our resolution to change the length of time for the distinguished ranks. However, we cannot change the guidelines until we receive final word from SUNY. The current length of service requirement for Distinguished Librarian states: Candidates must have completed at least five years of full-time service at the rank of Librarian (or full Professor with direct library responsibilities at a community college), have completed three years of full-time librarianship on the campus that

recommends the appointment, and at least ten years of service within the State University of New York. The proposed change: Candidates for all four Distinguished Professorship Ranks must have held the rank of Professor or Librarian for at least five years and must have at least three years of full-time service at the nominating institution.

- 2.3.9.2. The committee discussed possible ways of increasing diversity in the Distinguished Academy (DA), such as posting the Distinguished Faculty Award call to the diversity officer's listsery, educating and encouraging campuses to be more inclusive in nomination process via the Provost memo, and the DA could seek volunteers from its mentoring committee to focus on diversity. 2. Discuss revocation of Distinguished Faculty Award –
- 2.3.9.3. We discussed that need for submitting a resolution regarding revocation of a Distinguished Faculty award. However, after consulting with UFS, we learned that any revocation of title and impact on remuneration will have to be the result of a campus disciplinary procedure. In other words, in absence of disciplinary procedures the President cannot remove a person from rank. All campuses have disciplinary due process procedures already. Placing language in the guidelines would be redundant as the process applies to all ranks: assistant, associate, full, distinguished. Thus, we decided not to work on a resolution. 3. Discuss Shared Governance Award —
- 2.3.9.4. The primary focus of the committee's discussion has been focused on increasing the number of applications. P&A committee members who attended the Shared Governance Award committee meeting reported that members suggested that the award become part of institutions' orientation for their governance leaders. Other options to increase the number of applications are under discussion. In addition, to educate institutions, the document "What Shared Governance Is and Is Not" was added as an appendix to the application. 4. Discuss Conversations in the Disciplines –
- 2.3.9.5. Discussed ways to increase the number of applications, such as working with the UFS Communications Committee, and using press releases to announce recipients.
- 2.3.9.6. Discussed how we could further clarify the budget and unallowable costs.
- 2.3.9.7. The committed will ask for an increase in award funds to \$50,000.
- 2.3.9.8. Review Conversations in the Disciplines applications The committee will review applications on May 3.
